Requirements for teenage licensing:

Students 19 years of age are not required to complete Drivers Ed. program. They may hold a learners permit for 30 days and take road test at DMV.

CLASSROOM FOR STUDENTS 18 YEARS AND UNDER

Must complete 36 periods of classroom instruction. Each period consists of 50 minutes. Students may take a maximum of 4 periods per day on holidays or weekends. On weekdays only 2 periods of instruction may be completed.
Parents must attend 90 minutes Class with Student.

BEHIND THE WHEEL FOR STUDENTS 18 YEARS AND UNDER

Students must complete 7 periods of driving and 7 periods of observing another teen. Each session of driving or observing consists of 50 minutes. Driving test will be taken during the 7th driving session. Students must hold a Learners Permit for 9 months and be 16 years and 3 months old to be licensed. We must have 2 students in car for behind the wheel instruction. A student may ride alone in the vehicle with an instructor only to pick up another student. In car instruction should not exceed more than one period of driving and one period of observing within a 24 hour period. Each period consists of 50 minutes. We have 6 months to provide classroom or behind the wheel instruction. After completing the course we have 5 business days to issue the student a 180 day Temporary License. It's the parent's responsibility to contact the school if you haven't received a court hearing within 90 days of the validation date on the license. Extensions may not be given.

SCHEDULING APPOINTMENTS

It is the parent's responsibility to call our office at 703-892-2222 to schedule appointments Monday-Friday between 9am-6pm. After business hours you may leave a detailed message and your call will be returned within 48 business hours. DMV is committed to promoting transportation safety through the certification of the quality driver training programs. STUDENT/PARENT CONDUCT

Student and Parents must treat the Instructor and Staff members with respect. Foul language, intolerable behavior, threats, vandalism, harassment or any misconduct will breach the contract and no money will be refunded.

TERMS OF PAYMENT

All payments in full are due on the registration date. You may pay check, money order or cash.

- Fee for classroom instruction \$250.00
- Fee for behind the wheel \$280.00
- Classroom & Behind the wheel \$425.00

ADDITIONAL CHARGES

- Return check fee \$25.00
- Additional Driving Sessions: \$50.00 per 50 minute session
- If a student retakes the Drivers Test there will be a \$50.00 fee.
- A file search will be \$50.00
- Cancellation fee: You must cancel behind the wheel or classroom sessions 48 hours in advance. If not you will be charged \$50.00 per make-up session. All missed classroom or behind the wheel sessions must be made-up on makeup dates. You must contact office for makeup schedules. If student drops out of a class due to illness or family emergency and does not resume classes within 90 days, it is the student's responsibility to pay the difference if our rates have changed.

REFUNDS

If a refund is requested we will deduct \$50.00 per 50 minute classroom and behind the wheel or observation session the student took. No money will be refunded after the second session. You must submit a written letter to receive your refund. Your refund will be sent to you by mail only within 45 days.
